

Lobbying sought for Medicare reform

wanted to remind everyone of the Life Raft Group's efforts supporting the Access to Cancer Therapies Act of 2001.

The act, introduced in the House of Representatives as HR 1624 and in the

Senate as S 913, would extend Medicare coverage to all oral cancer drugs under Part B of Medicare. As of the beginning of this month, the bill had 237 co-sponsors in the House and 24 co-sponsors in the Senate.

Medicare now covers the cost of most cancer drug therapy because the drugs are administered through injections by providers. Since 1993, oral anti-cancer drugs have been covered only if they are available in both oral and injectable form. Gleevec, since its solely an oral drug, isn't covered.

You can show your support for HR 1624 and S 913 by calling your U.S. Representative or Senator if he or she

is not a co-sponsor of the act, and request that they co-sponsor this legislation. If they are already co-sponsors, you may want to call and thank them for their support and urge them to work for passage of these bills.

I contacted my senator's office and had a lengthy conversation with a staff member regarding what to expect when scheduling a visit. Each office handles this a bit differently though generally the same. Getting to meet the senator or congresspersons is not very easy. Typically an aide who is familiar with the issue will meet with you initially.

First step is to call for an appointment at your local field office. The next step will be a return call from one of the aides or staff to schedule the appointment. That's when you can briefly discuss the issue involved.

A confirmation call before your visit with the staffer will assure that the meeting is not overlooked and the staff person is prepared.

A typical meeting will last about 30 minutes. Have copies of your statement to leave with the aide. Request a follow-up response from the senator or congressperson.

Send a follow-up note to the office for their continued support or, hopefully, future co-sponsorship of this bill.

As a group we are small in number, influence, and resources. Individually, we have powerful stories to convey regarding oral cancer treatment. That is where we can make a difference in supporting this effort.

A tale of five Decembers

Editor's note: Marina Symcox posted this to the Life Raft Group and to ACOR's leiomyosarcoma support list 10 days before Christmas. It's worth sharing with those who haven't seen it. It's even worth reading again, at this most hopeful of seasons.

December 15, 1997: In the hospital, recuperating from a gastrointestinal resection, and terrified from the news that I have three to five months to live due to metastatic liver tumors.


December 15, 1998: I'm in the midst of a 10-day continuous infusion of DTIC ... ambulatory pump, ice packs, Zofran.

December 15, 1999: I am bedridden for the most part, and two months away from enrolling in hospice.

December 15, 2000: I am bedridden for the most part, but tumors are rapidly shrinking from Gleevec.

December 15, 2001: I swallow my morning dose of Gleevec and prepare for the big day. I attend my daughter's piano recital at Advent Christian Church, in Bristow America. Performers range from kindergarteners to 6th graders. My own daughter wears a blue velvet pant suit and black plastic slip-on shoes, high heeled, textured to simulate suede, and trimmed in rhinestones. I notice another child is wearing the same shoes. I notice most of the little girls are wearing holiday velvet outfits that I recognize from the racks at Wal-Mart. (In Bristow America, shopping is either the boutique Wal-Mart or a 40-minute drive to the malls in Tulsa.)

Most children haven't practiced their pieces nearly enough. My own daughter has a natural ability for singing on pitch. She amazes the crowd with her

rendition of "Jolly Old St. Nicholas" and "Good King Wenceslas," playing from one of those "big-easy-one-note-at-a-time" piano books, and singing brightly and energetically into the microphone, and of course with perfect pitch.

Victoria, from down the street, struggles with "Away in the Manger." Her parents, sitting behind me, hope that Victoria has learned a lesson about not practicing as she should.

The high performance of the afternoon, is offered by Hannah the kindergartener ... shorter and plumper than most 5-year-olds ... wearing a pink satin tea length dress ... not from Wal-Mart, but perhaps a leftover flower-girl dress from a spring wedding. Hannah sings "Silent Night," sometimes on pitch, but sometimes not ... that "sleep in heavenly peeeeace" section of the song is enough to strain even the most experienced vocal chords. Hannah wins the day with the biggest

smile, and the least inhibition about singing off-key.

Some of the worst music I have ever heard, and one of the best December 15ths that I have ever had.

Postscript December 16, 2001: I

have a middle school band concert this afternoon, in the high school gym. I can't wait to go, but don't believe they can out-perform Hannah in her satin pink dress.

A week ago the middle school band marched in the Bristow Christmas parade. The band was right behind the group of Harley-Davidson motorcycles decorated in battery powered Christmas lights and driven by the tattooed, leather-clad, bearded types that you normally associate with Harley-Davidson motorcycles. As you might imagine, 30 middle schoolers on clarinet and trumpet can't compete with the sound level of a dozen Harleys.

I never laughed so hard.




Meeting of minds at Dana-Farber

ife Raft Group Coordinator Norman Scherzer and Gilles Frydman, president of the Association of Online Resources, traveled to Dana-Farber Cancer Institute in Boston on Thursday, Dec. 13, to meet with Dr. George Demetri, medical director of the Center for Sarcoma and Bone Oncology.

Building upon many months of email and telephone interchanges, they met for more than four hours to discuss how to better respond to the needs of GIST patients and their doctors and nurses.

A major focus of the discussion was the feasibility of creating a non-profit organization to educate doctors and nurses about GIST, Gleevec and other new kinase inhibitors.

Also explored was the possibly of expanding upon the unique patient-driven data base created by the Life Raft Group. The day's discussions

Bruce Walter Gunn died Thursday, November 8, 2001, at home in Watsonville, California, U.S.A.

A native of Palo Alto, Mr. Gunn graduated from Gunn High School, named after his grandfather Henry M. Gunn, in 1976. He earned a bachelor's degree in forest management from Humboldt State University in Arcata, California in 1983.

He served with his wife as a Peace Corps volunteer in Honduras from 1987-89, where he implemented the first operative plan for Calaque National Park, the tallest mountain in Honduras. He refurbished an antiquated hydroelectric plant into a park visitor center there, which was later named for him.
